Club Response – 100% 22 Clubs Represented out of 28

9:00~ 9:30 - Discussion on Area Reps

Vision of Area Reps

Development, education and implementation of policies developed by the IPSC Ontario Board of Directors

Dom Accardo - why would we want to develop another layer of bureaucracy in our structure? Current membership numbers do not require another layer of management.

John Evers - with introduction of internet etc. area reps are no longer required, IPSC ON should embrace the communications technology available.

Ron Malloy - area reps are appointed by the board to act as liaison to the clubs. They provide a direct line of communication. Historically IPSC ON had 3 area reps and the activity was successful.

Gerard Levitt - there is no need for the additional layer with today's technology.

Rob Thomas - an additional layer of management is not required, we need to better utilize the tools that are already available to us eg. IPSC ON website - consider

benchmarking to the New Brunswick Website. Rob would like to see the IPSC ON Reps direct the board to investigate improvements during today's meeting.

Final Assessment - based on feedback Area Reps are not required. IPSC ON needs to develop current methods of communication to improve timing and content to the Club representatives as well as the IPSC ON membership.

Considerations:

Decision making on policy setting to be captured on the Website

IPSC ON – club rep forum page

IPSC ON- member's only forum

On decision making items no aliases should be utilized

Volunteers are needed to moderate the website

IPSC ON SitRep Publication: Is this publication still relevant in today's environment?

How would the elimination of the SitRep impact the membership?

Does it provide incentive to non-active members to participate in IPSC?

Would ending SitRep cut off communication to members and deter them from renewal? What would the impact to IPSC ON be regarding the potential lost revenues of members who would no longer be interested in renewal?

Is the concern SitRep or the level of involvement of our members in the sport? Are IPSC members holding their memberships to provide certification to the CFO?

Further evaluation of the benefit of SitRep is required – complete cost benefit analysis should be completed; we need to consider the population and the impact of removing the publication.

Confirmation should be completed to identify items of mandatory written communication: (consider in regards to constitution)

AGM, Membership Renewals, Elections Notifications, Match Notifications

9:30~9:50 - Level 3 Matches - How IPSC Ontario Contributes - Josko

Approximately \$6000.00 is contributed by IPSC ON to our annual ON Prov. Match Target profit to clubs 3~6K (Kingston 3K +1.5K to charity) (4.5K for Triangle)

Breakdown – immediate infusion \$1000.00 for booking etc.

\$2500.00 for rooming for CRO and support staff

\$2100.00 for trophies

\$ 500.00 for paper supply (score sheets etc.)

\$1000.00 patches etc.

Host clubs submit \$7.00 mission fees (target 200 competitors) back into IPSC ON Arbitration fees go to NROI Canada – based on result of arbitration

John Evers -Please explain the difference between ON Provincials and Level 3 in terms of what IPSC / NROI Canada provides.

- Where is this detail documented? Please provide detail to the club Reps.
- What is the organizational structure of IPSC and NROI Canada and what are their roles and responsibilities

Group Discussion

IPSC Incorporation / Constitution Status

- IPSC ON is currently not incorporated & is without a constitution
- This matter is currently with a lawyer and results of his findings will be shared at the AGM

Question: How was the lawyer selected Response - Independent lawyer who specializes in incorporation activity.

The constitution developed must be ratified by IPSC Canada.

May Russell – 6 years ago IPSC Canada requested IPSC ON to develop a constitution, to incorporate and get insurance.

Is IPSC Ontario incorporated, do they have a constitution and are they insured?

Please explain how we are going to present the constitution to the members, use of club representatives or alternate methods.

Direction from the B of D - continue to operate under the 1996 version until a new version is completed.

New Business - Membership renewal timing changes – change renewal timing to November 30^{th} with 1-month grace for complete sign-up. All membership renewals must be received by December 31^{st} .

Dave Huta - Ontario does not utilize World classifications to identify our top shooters therefore there is no benefit to Ontario to align ourselves USPSA.

- USPSA link is too close loose our IPSC ON sovereignty
- Selected stages can be practiced and perfected
- Selected stages do not support current IPSC rule book standards
- Concerned about space impact on indoor ranges

Mike Auger - USPSA classification system works and will provide ON shooters a classification system that is linked to the world performance.

John Evers - clarify if scoring must be submitted from match environment – no single submissions.

May Russell - shooters want a classification system that will work and give them a relative perspective to fellow members/competitors in their 'neighborhood' and the balance of the world shooters. If selected stages do not meet the rulebook the concern is in the link of ICS to IPSC since they are the standard for world classification.

Bernie DeGagne - the classification philosophy is strong - clubs can easily support

Rob Thomas - request clarification - Level 3 is not the only match where shooters are bumped - Response - adjustments are made based on performance (Level 3 exception - unless they exceed there current standing and win their category). What is Dave's alternative - Response - utilize previous version and make necessary adjustments.

Dom Accardo - does not agree with principal of the logic, does not support the logic, and believes we should investigate alternatives (ex. PAR scoring for golf courses).

Steve Morgan - agrees with the philosophy, the fact that masters are not required to enable scoring is a strong benefit.

Reg Lake - agrees with the philosophy, clubs could support this image.

Virgil Fala - constitution of IPSC ON and relationship to CFO already limits the variability and dictates a repetitive shooting environment. USPSA's pool of shooters enables a more accurate world classification.

John Esposito - no need to reinvent the wheel, USPSA classification has strong support and works.

Steve Russell - Develop IPSC ON standard stages vs. ICS / USPSA. Eliminate the ICS reference in the material presented to avoid a relationship and need to submit fees to ICS.

Len Walker - will legitimize IPSC in ON, it can be supported by the clubs, it can be repeated, remote clubs are supported by this logic and it evaluates the core principles of the sport.

Bernie DeGagne moves to accept the material presented by Mike Auger and to move forward with a new classification system for IPSC ON.

Bernie DeGagne - It would be beneficial to separate the club rep meeting by several weeks to allow clubs to feedback prior to the AGM.

Rachel Blum - Suggested that the next club rep meeting be held in September after the provincials and in preparation for the upcoming year.

Mark LaPointe - suggestion that IPSC ON hold club rep meeting three times per year - Response - balance of club representatives believe three meetings would be excessive and the B of D should target 2 meetings.

Dave Huta - Introduction of *New* IPSC targets

IPSC Mini targets for indoor ranges

< \$0.50 / target

Please order more than standard quantity as the "A" zone tatters quickly & the cardboard is thinner when compared to the standard IPSC classic targets.

Notes on Use: Cannot mix with standard targets in a course of fire

Recognized as IPSC targets

Standard rules for target replacement apply to mini targets

John Evers - please create a formal request to go to the World Board to allow standard and mini within the same course of fire.

Virgil Fala – Sanctioning

- contact information within SitRep is incorrect vfala50@gmail.com
- must meet a minimum 30 day requirement for course of fire submissions
- distance on all steel must be listed
- Sketchup free software on Google John Evers is strong user

Create a set of examples and send to all club reps. We should attempt to standardize between clubs. – Virgil to provide examples of both strong and weak submissions.

Josko - Question from some shooters regarding why are clubs loading multiple shooters hot? Feeling from the shooters is that this practice impacts the shooters, they don't like having hot shooters behind them as it breaks their concentration.

Dom Accardo - Running single shooters impacts our ability to run the match, we loose 1 min. per line consolidated vs. 1 min. x 3 = 3 min as single shooters. With 70 shooters in a day those lost minutes count and clubs need to take advantage of every opportunity.

Dave Huta – Rule 2.71 allows this practice – there are clear rules outlining running common firing lines. Clubs are requesting shooters load & make ready vs. telling, and shooters can refuse (within their rights) to run hot.

Message to reps. - time must never override safety eq. walking distance should be minimal.

Rachel Blum - CSSA newsletter – 9mil X 12 in a .40cal is not allowed in IPSC. Max 11 rounds in IPSC. Please communicate this to your members.
