Simar's name misspelled correction noted. Mayda asked if minutes posted Rachel stated Minutes posted as a draft only.

# 10:19 am – 11:00 pm - Black Badge Training Coordinator Report Kent's report

This year we have had 170 members take the Black Badge course since last April this does not include recertification, military members or juniors. This yea we have 30 new black

badge members, 10 courses planned so far this year. We have had 4 suspensions 2 recertification the system is working well. Income for black Badge course \$ 7200.00, 5,500 for expenses. The package for black badge costs \$100.00 per person. The cost for mailing the black badge to each member is \$6.00 Printing for the year \$3200.00 Kent request that match directors please include DQ's and results. Kent has been seeing some stages listed as zeroed all stages when the member has actually been DQ.

We have discussion on Kent's report regarding the following points by some of the reps:

- The number of DQ's whether to stay as is or have more DQ's
- put in our system as to why DQ and explanation
- suggested that Simar add this to the Forum and that he would setup a form to fill out.
- There should be a review after each DQ, review safety violation- so the shooter knows what he has done
- If unsafe he/she has to be reviewed
- DQ rules should be implemented on club match practice nights

• Concerns were raised about people being DQ on practice nights but not reported. DQ on a regular basis on a practice night should be reported

- club reps and match directors should be notified. Should lists those who are certified, those DQ and those who RO the member. Simar says he needs name of all club reps and match directors and he would add this to the forum.
- It was suggested to put in a rule suggested we should have a sheet with information at Black Badge courses for the member for all contact information. It was suggested adding it to the welcome package and will add all names and numbers

Rachel asked for volunteer to setup a rule she suggested Mayda as she likes how Mayda has it set up when she sends the matches results. Mayda lists those who certified, those DQ and those who RO and sends this along with the match results

Kent – rule has been in place before he took over, 2 shows as due diligence on our part. Once recertified cannot be DQ within a year shooter must shoot clean. Earle- remarked making everyone safe is important

Robert- safety is important we should close this discussion.

Eugene emphasized- everything discussed here should be brought up to club directors and club reps and match directors. Rachel communication needs to be forwarded to the club and board.

- May 7<sup>th</sup> & 8<sup>th</sup> will be the next level 1 which will be in Sudbury if you know anyone interested please let me know. The instructor will be Dave Huta. Please advise any IPSC members that may be interested in taking this course.
- Level 2 CRO course to be held either May or June
- There was two level 1 RO courses this year so far. Shane taught 7 students and Dave Huta taught in Burlington with 19 students

- Another call out for RO CRO June. One in Barrie
- Cro June-Grenville we have 65 eligible for this course
