The meeting called to order by the President at 19:04 EST, a quorum having been established.

Minutes of the last meeting:

- The minutes of the last meeting were read.
- A motion to accept the minutes as amended was made by Michael Galin, seconded by Kent Hill.

Black Badge Coordinator:

- The new exercises were posted to the Forum on March 13th.
- 14 badges have been issued so far

- The firm that we have hired to assist with web development has been granted access and is beginning work.
- There are some significant issues with the classification system. Pat and Chris have looked into the data and our classification system classes people approximately 15% too low. Pat will look into remedies.
- The Forum has been largely free of issues in the past month and meaningful discussion seems to be growing again.
