## Constitutional Amendment Re: Member Definitions

- The Board recognized that there is an emergency situation with respect to the lack of a definition of lifetime memberships, due to the long standing existence of such memberships that were bestowed in the past under previous constitutions.
- The issues was tabled until a special meeting to be called as soon as possible to deal with the issue.

#### Insurance Issues

- IPSC Ontario does not have a comprehensive general liability policy.
- Instructors are not covered by the regular CSSA policy.
- Len Walker will investigate how much the required policies would cost and the details of policies.

# Accounting Arrangements

• Len will retain the proper accountant for the preparation of tax returns.

# USPSA/Wentworth

• Wentworth is affiliating with USPSA so that they can hold USPSA classifier matches in addition to IPSC matches.

## Level 3 Cost Sharing

Motion by Adam Smith to fund Level 3 matches for out of town (50 km or greater distance)
dedicated staff (i.e. RM, CROs, Stats Officer, Quartermaster, and Chronograph Officer) for 50%
cost sharing with the match's host organization, on a single occupancy basis, with access to the
program made by application to IPSC Ontario by the match's host organization. Seconded by
Brad Sedore. Passed unanimously.

## Level 3 Kits

- No progress as of yet due to repeated delays in the process of getting a corporate credit card to facilitate purchases.
- Stavros will cut a cheque to Chris for \$2500 to cover an initial set of expenditures while awaiting the arrival of the credit card.

# Consideration of a member's suspension for safety infractions and their membership status

- A member appeared before the Board to discuss their current suspension for a history of numerous DQs
- The sequence of DQ history was:
  - o 2012-09-22 DQ
  - o 2014-08-23 DQ uprange 10.4.1
  - o 2014-09-27 DQ in unsafe direction 10.4.1 within 1 year of last DQ (suspension)
  - o Recertification with an instructor
  - o 2015-03-13 DQ for 10.4.3 within 1 year of last DQ (suspension)
  - Retook the Black Badge course
  - o 2015-12-18 DQ within 1 year for 10.4.1, 10.4.2, 10.4.6, 10.5.10 (suspension)
- The particulars of each DQ were discussed and the member was given a chance to speak to the Board to give their version of events.
- Len Walker moved that due to the ongoing safety risk constituted by the member, that the member be permanently expelled from IPSC Ontario under section 5g) i) of the IPSC Ontario Constitution. Seconded by Chris Recoskie. Passed unanimously.
