4. The objects for which the corporation is incorporated are:

- A. TO PROMOTE THE SPORT OF PRACTICAL SHOOTING IN ONTARIO.
 - B. TO PROMOTE RESPECT FOR THE PRINCIPLES OF THE SPORT OF PRACTICAL SHOOTING.
 - C. TO PROMOTE EDUCATIONAL PROGRAMS FOR THE BENEFIT OF THE MEMBERSHIP AND/OR FOR THE BENEFIT OF THE COMMUNITY.
 - D. TO PROMOTE AND TO CARRY OUT COMPETITIONS FOR THE BENEFIT OF THE MEMBERS AND THE MEMBERS OF OTHER LIKE ORGANIZATIONS.
 - E. TO PROMOTE AND ORGANIZE AND RUN AN INTERNATIONAL PRACTICAL SHOOTING CONFEDERATION CHAMPIONSHIP PROGRAM WHICH RESPECTS THE PRINCIPLES OF THE SPORT OF PRACTICAL SHOOTING.
 - F. TO PROMOTE AND CULTIVATE THE SAFE AND EFFICIENT USE OF FIREARMS BY PERSONS OF GOOD CHARACTER.
 - G. TO AFFILIATE WITH THE INTERNATIONAL PRACTICAL SHOOTING CONFEDERATION-REGION OF CANADA.
 - H. SUCH OTHER COMPLIMENTARY PURPOSES NOT INCONSISTENT WITH THESE OBJECTS.

5. The special provisions are:
Dispositions particulières:

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting its objects.

A. THE DIRECTORS SHALL SERVE AS SUCH WITHOUT REMUNERATION AND NO DIRECTOR SHALL DIRECTLY OR INDIRECTLY RECEIVE ANY PROFIT FROM HIS OR HER POSITION AS SUCH, PROVIDED THAT DIRECTORS MAY BE PAID REASONABLE EXPENSES INCURRED BY THEM IN THE PERFORMANCE OF THEIR DUTIES;

B. UPON THE DISSOLUTION OF THE CORPORATION AND AFTER THE PAYMENT OF ALL DEBTS AND LIABILITIES, ITS REMAINING PROPERTY SHALL BE DISTRIBUTED OR DISPOSED OF TO CHARITABLE ORGANIZATIONS WHICH CARRY ON WORK SOLELY IN CANADA;

C. FOR ATTAINMENT OF THE ABOVE OBJECTS, ANCILLARY AND INCIDENTAL THERETO;

D. TO ACCUMULATE FROM TIME TO TIME ALL OR PART OF THE FUNDS OF THE CORPORATION AND/OR THE INCOME THEREFROM AND TO INVEST AND REINVEST IN SUCH MANNER AS MAY FROM TIME TO TIME BE DETERMINED AND THE CORPORATION, IN MAKING SUCH INVESTMENTS, SHALL BE LIMITED TO INVESTMENTS AUTHORIZED BY LAW FOR TRUSTEES;

E. TO ACQUIRE, ACCEPT, SOLICIT OR RECEIVE BY PURCHASE, LEASE, CONTRACT, DONATION, LEGACY, GIFT, GRANT, BEQUEST OR OTHERWISE, ANY KIND OF REAL OR PERSONAL PROPERTY AND TO ENTER INTO AND CARRY OUT AGREEMENTS, CONTRACTS AND UNDERTAKINGS INCIDENTAL THERETO;

F. TO HOLD, MANAGE, SELL OR CONVERT ANY OF THE REAL OR PERSONAL PROPERTY FROM TIME TO TIME OWNED BY THE CORPORATION, AND TO INVEST AND REINVEST ANY PRINCIPAL IN SUCH MANNER AS MAY FROM TIME TO TIME BE DETERMINED AND THE CORPORATION, IN MAKING SUCH INVESTMENTS, SHALL BE LIMITED TO INVESTMENTS AUTHORIZED BY LAW FOR TRUSTEES;

G. TO SOLICIT AND APPLY FOR ALL LAWFUL AND NECESSARY GRANTS IN AID;

H. TO PURCHASE OR OTHERWISE ACQUIRE LAND FOR THE PURPOSES HEREIN AND TO LEASE, SELL OR OTHERWISE DISPOSE OF THE LANDS AND BUILDINGS UPON SUCH TERMS AS ARE DEEMED APPROPRIATE;


